EPHESIANS 6:5-9

Let's Get Started:

This week the apostle Paul continues to deal with the practical aspect of living a Spirit-filled life of submission and humility in relationships. In Ephesians 6:5-9, he turns our attention to work-related relationships. Most of us have found ourselves in a situation with an employer or as a volunteer, when we have felt unfairly or unjustly treated or unappreciated. In these verses, Paul is showing us that as Christians, our first obligation is to please God and be a faithful testimony to Him, and that includes the workplace. One way to do this, Paul says, is to give willing obedience to those under whom you work, regardless of who they are or the quality of their character.

In New Testament times, a bondservant could refer to someone who voluntarily served others. In most cases, however, the term referred to a person in a permanent role of service. In the Apostle Paul's day, a bondservant was considered the property of a Roman citizen. Most New Testament writers referred to themselves as servants, bondservants, or some form of a slave of Jesus Christ, as derived from the Greek word "dolous."
